

Focus: Frameworks Photography Contest

Official Rules & Regulations:

- 1. **Term of Contest:** Frameworks of Tampa Bay's (Frameworks) Focus Photography Contest. Entries accepted from Wednesday, February 1, 2017, through Friday, March 25, 2017. **No entries accepted after March 25, 2017.**
- 2. **How to Enter:** Submit a photo depicting an unselfish act to Frameworks of Tampa Bay following the instructions on the Frameworks website at www.myframeworks.org by 11:59pm EST March 3, 2017. Frameworks reserves the right to disregard any entry that is misdirected, illegible, incomplete or incorrect. Entries become the property of Frameworks.

3. What to Enter:

- Subject of the photo entry: "Unselfie." Each photo should convey an unselfish act whereby one person places another person's wishes above his or her own. Unselfish acts need not be completed by the contest entrant. Entrants are encouraged to use their creativity and imagination when determining what act to display in their "Unselfie" photo. See Frameworks' Call to Artist for more direction.
- Each photograph must include an individual artist statement explaining the photo, including the act portrayed and why. Please limit explanations to 150 words or less.
- One (1) submission per person.
- Participants must enter photos in one of two categories: manipulated or unmanipulated.
 - Unmanipulated photos must come from a single exposure, and may include minor adjustments including cropping and slight common adjustments to entire image (e.g. color, sharpening, desaturation, black and white).
 - Manipulated photos include images that are altered in any way, including duel images, double exposure, additions to the original image, and/or other manipulation to the original image.
- o Each photograph must be at least 300 dpi and in .JPEG format.
- Each participant under 18 must submit a parental release form indicating their parent or guardian's permission to participate in the contest. Consent forms are available on Frameworks' website, www.myframeworks.org.
- For a photo in which a person is recognizable, please secure a model release from the subject or in the case of a minor, the subject's parent or guardian and provide it to Frameworks upon request. Release forms are available on Frameworks' website at www.myframeworks.org.
- All images must be the original work of the photographer submitting it to the contest. If the judges ascertain this to be false, the entry will be removed from the contest.
- 4. **Eligibility:** Contest is open to any current middle or high school student living or in school in Hillsborough, Pinellas, or Pasco counties. Employees of Frameworks, its board of directors, and the immediate family and household members of each are not eligible. All federal, state, and local laws apply. Void where prohibited. Frameworks is not



responsible for printing, distribution or production errors and may rescind, cancel or revoke this contest based upon any such error without liability and at its sole discretion. By participating in this contest, entrants waive all right to, and hold harmless, Frameworks from any loss, damage or expense arising out of or in connection with participation in this contest or acceptance, use or misuse of any prize.

- 5. **Prize Details:** "Best in Competition" will be displayed on Frameworks' website, and will receive a \$200 gift card. "Fan Favorite" voted through the Frameworks' contest page will be displayed on the Frameworks' website and will receive a \$100 gift card. The top 20 photos will be displayed at Frameworks' EQ House at 402 East Oak Ave. in Tampa and used in educational materials. The top photos may be displayed at Frameworks' annual Head & Heart Awards Luncheon on April 20, 2017. "Best in Competition" and "Fan Favorite" winners will be chosen from the entire pool of entries and will not be separated by category.
- 6. Awarding of Prize: Frameworks will select one winner based on originality, technical excellence, composition, overall impact, artistic merit and as otherwise determined by the judges on or about April 3, 2017. The awarding of prizes will be juried by representatives of Frameworks. Decisions on all matters relating to this drawing are final. The winner will be notified via phone call. The winner agrees that Frameworks use his or her name and likeness for advertising and publicity purposes without additional compensation (except where prohibited). Acceptance of the prize indicates acceptance of all the contingencies described herein and inherent to the prize offered.
- 7. **Release:** By entering the Contest, entrant grants Frameworks the non-exclusive, royalty-free, and irrevocable right to use, reproduce, copy, publish, display, distribute, perform, translate, adapt, modify, and otherwise exploit the photo and to incorporate the photo in other works in any and all markets and media now or hereafter known worldwide in perpetuity. Entrants warrant that they have the sole and exclusive right to grant such rights to Frameworks, displaying, and/or other use of their photo will not infringe on any rights of third parties, including, without limitation, copyright, trademark, privacy, or publicity, or create claims for false light, idea misappropriation, defamation, intentional or negligent infliction of emotional distress, or breach of contract.

Entries must comply with all applicable laws, rules, and regulations. Frameworks shall have no obligation to copy, publish, display, or otherwise exploit the photo.

Entries must be received before 11:59 p.m. on Saturday, March 25, 2017, to be eligible for the Contest. No more than one (1) entry total per person shall be submitted. Multiple Entries received from any person, will void all such additional Entries. Entries that are incomplete, garbled, corrupted, or unintelligible for any reason including, but not limited to, computer or network malfunction or congestion are void and will not be accepted. Entry constitutes permission (except where prohibited by law) to use entrant's name, image and/or statement in any and all media now or hereafter known, throughout the world in perpetuity without additional compensation, notification, permission, or approval.
